#### **INSTRUCTIONS**

1. The candidates who desire to apply for Revaluation / Personal Identification and Retotalling / Retotalling should send their applications with prescribed fee to The Registrar, V.S. University, Nellore- 524 101, A.P. to reach on or before the date specified in the result copy. i.e. within 25 days, i.e. 20 days without fines, and 7 days with fines from the date of publication of results.

NOTE: The date of receipt of marks memorandum by the candidate will not be taken into consideration

2. I) Fee for Revaluation per paper
II) Fee for Personal Identification and Retotalling per paper
III) Fee for Retotalling per paper

**Revaluation** Means the University takes care to get the answer script revalued and informs the candidate whether there is effect or not, as per University rules.

**Personal Identification and Retotalling** means the candidates will be asked to identify whether the script belongs to him/her and the total of the marks posted by the Examiners on the first page is correct or not. Marks will not be shown on the first page or anywhere on the Answer script for P.G. Courses.

**Retotalling** means the University takes care whether the total of the marks awarded is correct or not and informs the candidate.

- 3. Fee once paid shall not be refunded under any circumstances.
- 4. Application received with insufficient particulars and fee will be summarily rejected.
- 5. There is no provision for revaluation of the Practical examinations except personal identification and retotalling /retotalling.
- 6. There result of the revaluation can be expected before the commencement of the next examination or later. Hence, the failed candidates who apply for revaluation are advised to pay the examination fee and appear for the examinations without waiting for revaluation results.
