3. **Obtaining Photocopy of the answer book is mandatory to apply for Revaluation.**
4. **There is no challenge valuation for U.G. & P.G courses.**
5. **The Photo copy shall be downloaded within one month from the date of hosting. Thereafter, it will not be available on the website.**
6. **Photocopy and Revaluation is not allowed for Drawing papers.**


