The Chairman of the Post Graduate Department is hereby informed that the forms of applications for admission to the university examinations can be had from the office of the Registrar (Evaluation), G.U. Kalaburagi on payment of Rs.50/- each by way of Bank challan/D.D in favour of Finance Officer, G.U. Kalaburagi, State Bank of Hyderabad, G.U. Kalaburagi.

The Chairman of the Post Graduate Department may forward the examination applications forms in one lot along with the fee including fee for statement of marks by separate D.D/Challan for examination within the due date after thorough scrutiny along with the list of candidates in Duplicate to the Registrar (Evaluation), G.U. Kalaburagi. They may note the following points while forwarding the examination application forms to the university.

- i. Change of center will not be permitted
- ii. The true copies should be signed and attested by the concerned Chairman only.
- iii. In support of passing the lower examination and for claiming exemptions etc., attested true copies of the marks card should be enclosed to the examination application, failing which the applications of such candidates will be rejected.
- iv. Applications should be scrutinized properly before they are sent to examination branch.
- v. Continuity of Sl. Nos. on the examination application forms should be maintained.
- vi. Combined Demand Draft in respect of examination fees should not be sent. Separate D.D. should be sent in respect of each examination.
- vii. The Chairman of the Post Graduate Department is required to sign on the photos of the candidates affixed on the admission card without fail.

The candidates belonging to SC/ST are exempted from payment of examination fee. However they shall pay the fees for examination application form, marks card fee, and scrutiny fee. The Chairman of the department is requested to claim the amount for such students who are exempted from examination fee from the concerned departments of Govt. of Karnataka and remit the same to the undersigned after grant is received or otherwise this office will be constrained to collect the amount from department. The financial statement in respect of such students who have claimed exemptions from the payment of examination fee shall be submitted to the undersigned separately and copy to the Finance Officer, G.U. Kalaburagi. The candidates claiming fee exemptions have to submit the Caste certificates compulsorily. **(The fee exemption is not applicable to Part-Time Candidates).**

Rs.6/- out of Rs.12/- collected from the each candidate towards scrutiny of applications may be sent separately to the Registrar (Evaluation) by means of D.D. in favour of Finance Officer, G.U. Kalaburagi.

Applications should be forwarded to the undersigned through the Chairman of the P.G. Department. They should not be submitted to the undersigned directly by the candidate.

The Chairman of P.G. department is requested to bring to the notice of the candidates that the candidates of M. Phil need to write their examination in English. M. Phil candidates in language may write their examinations in respective languages concerned.


They are further requested to inform the candidates who write the papers in any medium other than English, their performance at the examination shall be cancelled.
