The Andhra Pradesh Public Service Commission conducted Preliminary Examination (Screening Test) for recruitment to the posts under Group-I Services, (Notification No.28/2022) today i.e. on 08/01/2023 FN & AN. Against **1,26,449** candidates registered for the examination, **1,06,473** have downloaded the Hall Tickets and **87,718** have appeared for the examination (**82.38%**). The examination was held at 297 venues in 18 Districts of Andhra Pradesh.
