As per reference cited the Non- Autonomous Affiliated M.Tech & M.Pharmacy colleges and Pharm-D & Pharm-D(PB) colleges are permitted to collect the following fees from the students admitted during 2022-23 academic year.

- (i) Rs.2000/- per student shall be collected from the first year students as one time fee. Out of this Rs.2000/- the colleges shall retain Rs.1500/- and pay Rs.500/- to the university.
- (ii) Rs 1500/- per annum per student shall be collected by the Non- Autonomous Affiliated colleges during the entire course, (from first year to final year) towards the Common Services Fee and the same shall be remitted to JNTUH.
- (iii) The Principals of the affiliated colleges shall be informed to get the list of admitted students verified by the Admission Section of JNTUH for the Academic Year 2022-23 and submit the same to the clearance section, Examination Branch JNTUH.

The Non-Autonomous Affiliated Colleges have to clear all the pending dues of Common Services Fee till end of the academic year 2022-23. They have to submit the details of students pursuing their II, III, IV, V, VI year during the academic year 2022-23. They have to pay the Common Service Fee pertaining to them.

The requisite fee is to be paid, through RTGS /NEFT Payment mode in favor of “The Registrar, JNTUH, A/c No: 62079988622, State Bank of India, JNTU Campus Kukatpally Branch, IFSC Code: SBIN0021008 ” or in the form of a D.D., drawn on any nationalized bank, in favor of “The Registrar, JNTUH”, payable at Hyderabad.
