SPECIAL INSTRUCTIONS TO THE PRINCIPALS

- The College login will be closed after the last date.
- Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, if they write the examination.

NOTE:-

1. The students are advised to enclose Xerox copies of their qualifying examination certificate copies duly attested by the College Principal concerned.
2. The Principal is requested to send the Faculty list without which the examination forms will not be accepted.

3. The Principal is requested to verify the eligibility of the students thoroughly and forward the same to this office for the issue of Hall Ticket. If failed to verify the eligibility of the candidates, the principal is held responsible for the issue of hall ticket by this office to the non-eligible candidates.
4. The Principal may kindly forward all the examination application forms **online Through College login**
5. **All the college Principals are requested to collect the examination Processing fee of Rs.300/- and Migration fee of Rs.125/- from the students per head and remit the consolidated amount to the registrar exam fee fund A/C, OU together with examination fee and application form in terms of OU Circular No.3872/D/37/93/Acad., dt. 15-12-1993.**
6. The Principal may kindly forward all the examination application forms along with the Prescribed examination fee on or before **31-12-2022** together with Nominal Rolls.
7. The Colleges maintaining their account with the branches of State Bank of India (SBI) OR Any other bank are required to deposit the consolidated amount in any branch of SBI for Credit into **"Registrar, Examination Fee Fund A/c No.52198262033"** and can obtain a receipt from the bank and submit the same to the Examination Branch along with Examination forms on or before **31-12-2022**

Applicatins forms submitted after 31-12-2022 will have to pay a panel fee of Rs.5000/- perday

8. The students who were transferred from the University Jurisdiction and other Universities their examination forms should be submitted separately with the Approval of the competent authorities like commissioner of Tech. Education, Govt. of T.S. and Director Academic Audit, O.U. with allotment of H.T. No.s.
9. As a part of the core Banking System, all the students are hereby instructed to deposit the Examination Fee into their respective college accounts only for onward transmission to the University by the College.
10. **Not to collect the Exam fee form Blind/Physically Disabled Deaf & Dumb students as per O.U. Order No. 1555/228/2007-08 /Budget-V, dated: 25-03-2008. A Xerox copy of medical Certificate confirming their status. as handicapped (minimum percentage of disability must be of 40%attached to the application forms).Blind/ Physically Disabled, Deaf & Dumb Students applications forms should be submitted separately along with separate Nominal Roll.**

Any discrepancies with regards to the Candidate data such as Internal marks, Practical, Viva-voce and Projects etc. should be brought to the notice of concerned officials of Examination Branch and obtain the acknowledgement within two weeks of declaration of the results. After two weeks, queries will not be entertained.
