SPECIAL INSTRUCTIONS TO THE PRINCIPALS

- ❖ The college login will be closed on 27-03-2023 by 5.00 PM.
- ❖ The late fee amount will be levied automatically in case the fee is not remitted to the O.U. A/c and forms are not submitted as per the above schedule.
- Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, if they write the examination
- The College will be held responsible for any mistake committed while filling the Candidate's name, Mother's name, father's name and paper title (Theory & Practical) through ONLINE. IN CASE OF ANY MISTAKE RS. 500/- will be levied as FINE for rectification of each error.

<u>Fee Structure: -</u>

1. LL.M all Branches of I-Semester is Rs. 1150/- + Rs.150/- (Memo Charges) + Rs. 100/ (Biometric Fee) + Rs.500/- towards Examination processing fee (once in a course time) Total fee is Rs.1900/- (Migration fee of Rs. 250/- along with Original Migration Certificate for other than OU students) Total fee is Rs. 2150/-.

Note: The Principals are requested to submit the I-Semester Internals award Lists of LL.M students along with the examination Application forms on or before <u>27-03-2023</u>. Otherwise the college has to pay Rs.1000/- per day as Penalty for Late Submission of award lists.

Not to collect the Exam fee from Blind, Physically Disabled, Deaf & Dumb students as per O.U Order No. 1555/228/2007-08/Budget-V, dated: 25-03-2008. A Xerox Copy of Medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb Students Application forms should be submitted separately along with Separate Nominal Roll.

. Important Note:-

- 1 The Examination Application Forms (EAF) are to be submitted online through college login. Also, hardcopy of the same may be downloaded and must be kept with concerned college principal.
- 2 The concerned Principal's required to transfer the fee amount through the Application (Online payment options Net Banking or RTGS) only.
 - a. If the College makes the payment through online, there is no need to submit any document (for proof of Fee).
 - b. However, if the College makes the payment through RTGS/NEFT, they have to submit (1) Fee abstract (Downloaded from the college login), (2) Download from College Login, Exam Branch, O.U.
- 3 Principals will be held responsible for any lapse in transfer of amount from the banks to the Registrar Exam Fee Fund Account.

The Principals are requested to pay the examination fee for received application forms and **not to pay the**<u>The Principals are requested to submit the</u>

- a. Latest Affiliation orders with intake approved by the University
- b. "No Dues Certificate" of LL.M I-Semester all courses from the Deputy Registrar (Academic), O.U.
- c. List of admitted candidates duly approved by the Director, Directorate of Admissions, O.U.
- d. Clearance Certificate issued by the Director, Directorate of Academic Audit, O.U.
- e. The Principals are requested to verify the names of the candidates in examination forms and Hall Tickets on par with the Qualifying Certificate, and enclose Xerox copy duly attested for Verification.
- f. Name List (Nominal Roll), Subject-wise data.
- 5 Fresh candidates appearing for <u>I-Semester</u> shall enclose Xerox copies of their qualifying Degree Certificates (i.e. provisional & Convocation certificates) duly attested by the Principal of College concerned. Other University candidates should enclose their <u>Original Migration Certificate</u>, and has to pay migration fee of Rs.250/- in addition to the examination fee.
- 6 Any discrepancies with regards to the candidate data such as internal marks. Should be brought to the notice of concerned officials of examination branch and obtain the acknowledgement within 15 days of declaration of results. After 15 days, queries will not be entertained.
