SPECIAL INSTRUCTIONS TO THE PRINCIPALS

- ❖ The college login will be closed on 17-10-2022 by 5.00 PM.
- ❖ The late fee amount will be levied automatically in case the fee is not remitted to the O.U. A/c and forms are not submitted as per the above schedule.
- ❖ Principals are requested not to forward/submit the EAF of Not Eligible Candidates. The results of Not Eligible candidates will be cancelled at any stage, if they write the examination.

Examination Fee Particulars:

1. Examination fee for LL.M IV Semester Regular Exam Fee is Rs.1030/- + Rs.200/- (Thesis) + Rs.150/- (Provisional certificate) + Rs.100/- (Memo of Marks Charges) + Rs. 100/ (Biometric Fee) + Alumni fee Rs. 100 + Rs.50/- (Viva-Voce) Total fee is Rs 1730/- (Rs.50/-towards Viva-Voce should be retained by the principal of the concerned college) + Rs. 500/- (Consolidated memo) = **Total fee is Rs 2230/-.**
2. LL.M II Semester Regular Exam Fee is Rs. 1030/- + Rs.100/- (Memo Charges) + Rs. 100/ (Biometric Fee) Total fee is Rs. 1230/-.
3. LL.M I, II, III & IV Semester Backlog and Improvement Exam Fee is Rs. 1030/- + Rs.100/- (Memo Charges) Total fee is Rs. 1130/-.

Not to collect the Exam fee from Blind, Physically Disabled, Deaf & Dumb students as per O.U Order No. 1555/228/2007-08/Budget-V, dated: 25-03-2008. A Xerox Copy of Medical Certificate confirming their status as Handicapped (minimum percentage of disability must be of 40%) must be attached to the Application forms. Blind, Physically Disabled, Deaf & Dumb Students Application forms should be submitted separately along with Separate Nominal Roll.

.. Important Note:-

- 1 The Examination Application Forms (EAF) are to be submitted online through college login. Also, Hard copy of the same may be downloaded and must be kept with concerned college principal.
- 2 The concerned Principal's required to transfer the fee amount through the Application (Online payment options Net Banking or RTGS) only.
 - a. If the College makes the payment through online, there is no need to submit any document (for proof of Fee).
 - b. However, if the College makes the payment through RTGS/NEFT, they have to submit (1) Fee abstract (Downloaded from the college login), (2) fee receipt issued by the D.R Cheque II section, Exam Branch, O.U.
- 3 Principals will be held responsible for any lapse in transfer of amount from the banks to the Registrar Exam Fee Fund Account.

The Principals are requested to pay the examination fee for received application forms and not to pay the Fee for un-received application forms

Note: - The Principals are requested to submit the II & IV Semester Internals Award Lists of LL.M all Branches students along with the examination Application forms on or before 17-10-2022. Otherwise the college has to Pay Rs.1000/- per day as Penalty for Late Submission of award lists.
