Important Note:-

- 1. The Examination Application Forms (EAF) are to be submitted online through college login. Also, hardcopy of the same may be downloaded and must submit hard copies of EAF applications forms to the Examination Branch, O.U.
- 2. The concerned Principal's required to transfer the fee amount through Online/ RTGS / NEFT for credit into Registrar Osmania University Exam Fee Fund Account.
 - a. If the College makes the payment through online, there is no need to submit any document (for proof of Fee).
 - b. However, if the College makes the payment through RTGS/NEFT, they have to submit (1) Fee abstract (Downloaded from the college login), (2) fee receipt issued by the D.R Cheque II section, Exam Branch, O.U.

- 3. Principals will be held responsible for any lapse in transfer of amount from the banks to the Registrar Exam Fee Fund Account.
- 4. The Principals are requested to submit:
 - i. Name List (Nominal Roll)
 - ii. Subject-wise data
 - iii. Fee Abstract (Download from the College login), Fee Receipt issued by the D.R. Cheque II Section, Examinations Branch, OU.
 - iv. A copy of OU Affiliation Orders for the Academic Year 2022-2023
 - v. No Objection Certificate from the Director, Directorate of Academic Audit, OU.
 - vi. The list of candidates admitted to I-Semester for the academic year 2022-23 signed by the Director, P.G. Admissions, OU.

The College will be held responsible for any mistake committed while entering the Candidate name, mother name, father name and paper title (Theory & Practical) through ONLINE. IN CASE OF ANY MISTAKE RS. 500/~ will be levied as FINE for rectification of each error.

- 5. A Penal fee of **Rs.5,000/- per day** shall be levied if the college fails to submit the Examination application forms within the stipulated date.
- 6. Fresh candidates appearing for <u>I-Semester</u> shall enclose Xerox copies of their qualifying Degree Certificates duly attested by the Principal of College concerned. Other University candidates should enclose their <u>Original Migration Certificate</u>, and has to pay migration fee <u>of Rs.250/-</u> in addition to the examination fee.
- 7. Name of the Candidate and Father's Name should be same as in the **Qualifying Degree** Certificate.
- 8. The Colleges are required to enclose the Clearance Certificates issued by the Stores Section of the Examination Branch as a proof for the unused examination stationery returned by the college pertaining to the examinations conducted earlier.
- 9. The Principal is requested to submit the fee for received application forms only and not to pay fee for un-received application forms. <u>ANY EXCESS FEE PAID CANNOT BE REFUNDED OR ADJUSTED FOR ANY FUTURE EXAMINATION.</u>
- 10. ANY DISCREPANCIES WITH REGARD TO THE CANDIDATE DATA SUCH AS INTERNAL MARKS, PRACTICAL, AND PROJECTS ETC. SHOULD BE BROUGHT TO THE NOTICE OF CONCERNED OFFICIALS OF EXAMINATION BRANCH AND OBTAIN THE ACKNOWLEDGEMENT WITHIN 15 DAYS OF DECLARATION OF RESULTS. AFTER 15 DAYS, QUERIES WILL NOT BE ENTERTAINED.
