B.E ONE TIME CHANCE NOTIFICATION

It is hereby notified for the information of all the concerned that the Standing Committee of the Academic Senate at its meeting held on 22-10-2022, has resolved to permit the B.E students to appear for their backlog papers, even after the stipulated period as a One Time Chance.

Hence, **BE (Non-CBCS) students who have admitted during academic year 2010-11, 2011-12, 2012-13 in First year, B.E Lateral entry students admitted directly into 2nd year during the academic years 2011-12, 2012-13 & 2013-14 and also B.E (CBCS) students who have admitted during academic year 2016-17 in First year, B.E Lateral entry students admitted directly into 2nd year during the academic year 2017-18** are eligible to appear in the ensuing examination, with a penal charges of **Rs. 10,000/- per paper**, in addition to the normal examination fee, as a **One Time Chance**, with the existing syllabus/scheme.

The examinations will be conducted in the month of February 2023. The detailed time table will be issued in due course. **This notification is meant for backlog candidates only. Fee once paid will not be refunded or adjusted.**
