**ORDER:-**

Orders were issued in the reference 1<sup>st</sup> read above for enhancing the remuneration to the persons working on Contract and Outsource basis in the categories of Junior Assistant / Typist / Junior Steno / Senior Steno / Driver / Office Subordinate (Attender / Last Grade Services) / Lift Operator / Data Entry Operators / Data Processing Officers. In the para 6 of the said G.O. it has been mentioned that, in respect of the categories other than those mentioned above, the remuneration shall be fixed not exceeding the minimum of the time scale attached to the post in Revised Pay Scales 2010.

2. In the reference 2<sup>nd</sup> read above, the Secretary, APSWREIS, Hyderabad has submitted the following proposal for enhancement of remuneration to the staff engaged on contract basis, the approved minimum time scale of pay in RPS 2010 for each category i.e.,

Social Welfare Residential Educational Institutions Society shall be fixed as indicated at column 4 in respect of following categories.
