**ORDER:**

In the Government order first read above, orders were issued sanctioning an amount of Rs.100/- per month as Supervisory Allowance to certain categories mentioned therein based on the recommendations of Pay Revision Commission, 2010.

2. In the Government order second read above, based on the recommendations of Tenth Pay Revision Commission, orders were issued for implementing the Revised Pay Scales, 2015 to the State Government Employees.

3. Among others, the Tenth Pay Revision Commission, recommended for enhancement of Supervisory Allowance from Rs.100/- to Rs.150/- per month to certain category of posts working in the Local Bodies, Municipalities and Municipal Corporations.

4. Government have accepted the recommendation of Tenth Pay Revision Commission and hereby order that the following categories of employees shall be sanctioned Supervisory Allowance at the rate of **Rs.150/- per month.**
