The eligible candidates have to attend the Admission Counselling with all the original certificates and fee payable i.e., **Rs 3,800/-**. **(However, the fee chargeable shall be as fixed by the Government and applicable at the time of admission)** at the respective polytechnics on **11-08-2011** at 10:00 A.M.

Candidates belonging to SC/ST/BC/EBC/Minority categories will be exempted from payment of tuition fee & special fee, in case, the income of their parents is within the prescribed limit of Rs. 1,00,000/- per annum and a certificate issued by the concerned Tahsildar / M.R.O. is to be produced to that effect. The candidates, so admitted under fee exemption category, are instructed to apply to Government for fee reimbursement online through <http://ePass.cgg.gov.in> or www.apsmfc.com, as the case may be. However, such candidates have to necessarily pay admission fee, syllabus book, Board recognition fee, and alumni fee i.e., Rs. 500/-. **(However, the fee chargeable shall be as fixed by the Government and applicable at the time of admission)**
