The Competent Authority i.e APSICHE has been receiving complaints from the students that certain Managements of Professional colleges are demanding to pay additional amount over and above the prescribed special fee when they reported for admission which is clear violation of Government orders.

As per the Government order in reference (1), the Government has categorically specified that the Tuition fees shall include all fees which are non refundable and will be reimbursed to the colleges for the students found eligible on verification.

The Government letter vide reference (2) cited, reiterated that Government will reimburse the non refundable Special fees and directed the Private Professional Institutions **not to collect the special fees from the eligible students who are covered under RTF (Reimbursement of Tuition Fee) scheme.**

In this regard, all the managements offering both UG & PG Professional courses are required to strictly abide by the above Government directions.

I am by direction, to request the University, Convener of the CET admissions concerned and the Associations of Managements of Private Professional colleges in the State to direct all the concerned not to collect any excess fee from the students other than the prescribed by the Government.
