 examination.

NOTE:-

- CBCS 16 & 17th Batch studens need not apply. The maximum number of attempts are treated to (No.of years course + 2 year)
- The students are advised to enclose Xerox copies of their qualifying examination certificate copies duly attested by the College Principal concerned.
- ❖ The Principal is requested to send the <u>Faculty list</u> without which the examination forms will not be accepted.
- The Principal is requested to verify the eligibility of the students thoroughly and forward the same to this office for the issue of Hall Ticket. If failed to verify the eligibility of the candidates, the principal is held responsible for the issue of hall ticket by this office to the non-eligible candidates.
- The Principal may kindly forward all the examination application forms online Through College login

- ❖ The Principal may kindly forward all the examination application forms along with the prescribed examination fee on or before 04-08-2022 together with Nominal Rolls.
- ❖ The Colleges maintaining their account with the branches of State Bank of India (SBI) OR any other bank are required to deposit the consolidated amount in any branch of SBI for Credit into <u>"Registrar, Examination Fee Fund A/c No.52198262033"</u> and can obtain a receipt from the bank and submit the same to the Examination Branch along with Examination forms on or before 07-12-2022.
- Application Forms submitted after 04-08-2022 will have to pay a Penal fee of Rs. 5000/- per day.
- * As a part of the Core Banking System, all the students are hereby instructed to deposit the Examination Fee into their respective college accounts only for onward transmission to the University by the college.
- Not to collect the Exam fee form Visually/Physically Challenged and Hearing Impairment students as per O.U. Order No. 1555/228/2007-08 /Budget-V, dated: 25-03-2008. A Xerox copy of medical Certificate confirming their status. (minimum percentage of disability must be of 40%attached to the application forms). Visually/ Physically Challenged and Hearing impairment students applications forms should be submitted separately along with separate Nominal Roll.

- Any discrepancies with regards to the Candidate data such as Internal marks, Practical, Viva-voce and Projects etc. should be brought to the notice of concerned officials of Examination Branch and obtain the acknowledgement within one month of declaration of results. After one month, queries will not be entertained.
