B.E ONE TIME CHANCE NOTIFICATION

It is hereby notified for the information of all the concerned that the Standing Committee of the Academic Senate at its meeting held on 22-10-2022, has resolved to permit the B.E students to appear for their backlog papers, even after the stipulated period as a One Time Chance.

Hence, BE (Non-CBCS) students who have admitted during academic year 2010-11, 2011-12, 2012-13 in First year, B.E Lateral entry students admitted directly into 2nd year during the academic years 2011-12, 2012-13 & 2013-14 and also B.E (CBCS) students who have admitted during academic year 2016-17 in First year, B.E Lateral entry students admitted directly into 2nd year during the academic year 2017-18 are eligible to appear in the ensuing examination, with a penal charges of Rs. 10,000/- per paper, in addition to the normal examination fee, as a One Time Chance, with the existing syllabus/scheme.

The examinations will be conducted in the month of February 2023. The detailed time table will be issued in due course. This notification is meant for backlog candidates only. Fee once paid will not be refunded or adjusted.
