*In addition to the Examination fee, each candidate appearing for I-Semester Examination for the first time is required to pay Rs.500/- Examination processing fee (once in a course time).

The Blind, Physically Disabled, Deaf & Dumb students (who have 40% of minimum Disability) need not pay Examination Fee as per O.U Order No.1555/228/2007-08/Budget-V, dated: 25-03-2008. A Xerox Copy of Medical Certificate must be attached to the EAF.

ALL THE REGULAR CANDIDATES OF I-SEMESTER SHOULD SUBMIT THEIR EXAMINATION FORMS THROUGH ONLINE ONLY.

The College will be held responsible for any mistake committed while filling the candidate name, mother name, father name and paper title (Theory & Practical) through ONLINE. IN CASE OF ANY MISTAKE RS.1000/- will be levied as FINE for rectification of each error.

Fresh candidates appearing for <u>I-Semester</u> shall enclose Xerox copies of their qualifying Degree Certificates (i.e. provisional & Convocation certificates) duly attested by the Principal of College concerned. The other University candidates should enclose their <u>Original Migration Certificate</u> together with a fee of Rs.250/- in addition to the examination fee.

- iv) The clearance certificate from the Director, Directorate of Academic Audit, O.U.
